Will and inventory of Christopher Weatherel, 1727

In the Name of God Amen. I Christopher Weatherel in the Constablery of Little Ayton in the parish of Great Ayton in Cleveland in Yorkshire, yeoman, being sick and indisposed in Body, but sound in mind, and in the Exercise of my Reason, and perfect in Memory; do hereby make this my last will and testament.

I give and commit my soul to God, Hoping for Salvation upon the Account of the Mercies of God, and the Merits of Christ the Common saviour, and my Body to be interred at the discretion of my Executors after mentioned.

And out of that Estate God has been pleased to give me, I Bequeath to my Eldest Lawful son Thomas Weatherel the sum of five shillings.

I set to the three children of my son Thomas Weatherel three shillings.

I give to Mary King the daughter of Marmaduke King a cup board and three pounds when she shall be at the age of one and twenty years.

I set to Marmaduke King one shilling.

I Bequeath to Christopher King the sum of one shilling, and to his two sons Christopher King and Thomas King each of them a shilling.

And finally I nominate Constitute and Appoint my second son James Weatherel my sole and only executor of this my last will and testament, and do hereby give Him all my Estate Real and personal, my debts Legacies and funeral charges being by Him to be paid. And if He the said James Weatherel shall die without Heirs, then the foresaid Estate Real and personal is to fall to the next of Kindred.

In witness whereof I have set my mark and seal to these presents this seventh day of January one thousand seven hundred and twenty seven years in the presence of us.
