John Kearton versus William Belt in a plea of trespass to damage of 39/111/2d. They reach agreement.

Thomas Colling versus Dorothy Sheels in a plea of trespass to the damage of 10s which she owed him according to a promise made to the plaintiff on 20th June 1650, in consideration whereof the plaintiff paid 10s to Henry Whitton of Guisb. The defendant makes default and says nothing, and the bailiff is therefore ordered to levy 10s for debt and 10d fine.

William Younge of Ayton versus James Harrison of the same in a plea of trespass with damages of 10s because the defendant on 20th September 1650 broke his enclosure and there cut the growing corn and carried it off. The defendant withdrew in contempt of court. Verdict for the plaintiff, 1/6d for damages.

Henry Gray of Ayton versus Charles Harrison of the same in a plea of debt of 2/6d which he owes him and unjustly detains and which the defendant accepted by agreement on 30th April 1650. Plaintiff seeks and is granted execution for the said damages and 1/10d fine.
