The Vestry

In the parishes and the villages from the 14C onwards there was a tradition of local self government, in the sense that the maintenance of village life – the repair of local footpaths and bridges, the care of straying animals, the planting of crops, etc – was a matter of local self-help. In the 16C and 17C a great body of new legislation was forced through parliament which encouraged the development of secular parochial authority administered through 'vestries'.

In the government of the parish there were two legal factors: the right of the inhabitants to participate in parochial business, and the duty of inhabitants to participate in the carrying out of the parochial offices, namely, Constable, Churchwarden, Overseer of the Poor and Surveyor of the Highways, in effect the first tentative steps towards democracy for the common people. The open parish vestry was the only asembly, other than the House of Commons, which had the right to impose taxation.

In practice the politics of the village reflected the economic and social order of the village. There was usually a small oligarchy of intimate friends and neighbours, the tenants of the squire, the employers of pauper labour, presided over by the clergyman or senior churchwarden and perhaps dominated by the local Justice of the Peace.

Generally the rural parish oligarchies grew into orderley 'open vestries'. However, in some instances, local inhabitants of importance or influence appropriated powers to themselves and were able to control their fellow parishioners. These 'close or 'select vestries', more common in populous urban parishes, were bodies of a dozen or more persons, serving for life and filling vacancies by co-option. The 'select vestry' could become corrupt and pervert parish administration in order to take advantage of their neighbours.

The 'open vestries' in stable rural communities were able to get round the drawbacks of compulsory and unpaid local service in parochial offices. They allowed any formal holder of an office to employ an assistant or if, for example, the bridge-building or road mending was too difficult, the work might be farmed out to a contractor. Corrupt vestries however could turn the principle of compulsory service into a source of revenue for themselves.

The posts of Constable and Overseer of the Poor were often so onerous that, in the 18C, they generally were allotted throughout the parish in rotation. This system usually worked well in rural communities where everyone knew each other. If any problems arose, the authority of the local Justice of the Peace could be invoked, thus providing a degree of stability.

The civil and ecclesiastical components of vestral authority were separated by the Municipal Corporations Act of 1835 which consolidated urban parishes into boroughs and the Local Government Act of 1894 established civil parish councils of elected members in rural areas with a population exceeding 300. Since 1919 the administration of the ecclesiastical parishes has been vested in parochial church councils.

In the Churchwardens' Accounts for 1827—28 there are two entries relating to the above minutes. The first an entry on Jan. 22^{nd} , 1828, 'Mr Pratt for Advertising Breaking Church , 16s-3d.' William Pratt was a printer and publisher in Stokesley and would have printed a notice about the break-in at the church in a local publication. The second entry on July 9^{th} , 1828 'Pd Pollice Officer at Stockton

2s-6d' possibly indicates a Stockton connection with the break-in.

At a Vestry Meeting held in the Parish Church of Great Ayton, pursuiant to the notice given on Wednesday the 27th of Feb,1828.

- 1 That the Meeting approves the adoption of the service in the evening with a lecture in the place of the afternoon prayers.
- 2 That the Meeting approves the proposal of Mr Ibbetson to pay himself one half of the expense of providing the needful lamps and candlesticks etc and the oil and candles wanted, and that the other half be paid out of the Rate.
- 3 That this Meeting authorizes the churchwardens to pay one Pound out of the Rate for repaying the expense of teaching the children and others to sing.

Resolved that where it has been the custom to collect throughout the Parish or Township of Great Ayton one shilling on every person occupying Lands, or House and lands together, and sixpence on every person occupying a Cottage. But on taking the matter into consideration and in order to relieve the labouring poor , it is agreed; that in future the sum required shall be taken from the poor rates or otherwise raised, the amount of which shall not at any time exceed the sum that can or may be collected in the old established customary manner, and that the Townships of Little Ayton with Tunstal and Nunthorpe shall and in equal parts raise a sum equal to Great Ayton as has been accustomed formerly to be done, which sums together if at any time should not be sufficient to defray the necessary expenses in supporting the Church then such further sums wanted over and above the sum raised as before mentioned shall be collected in Great Ayton, Little Ayton With Tunstal and Nunthorpe respectively by an equal Rate of so much in the pound as has heretofore been the custom. It is also further to be observed, that in taking the customary sum out of the Poor Rate or otherwise paid as before mentioned it is not intended to set aside or do away with the old established custom but merely to be considered as a casual relief to the Poor and may be to at any future period.
